The institution namely Aastha College of Education, Village-Damla, Post-Damla, Tehsil-Jagadhri, District-Yamuna Nagar, District-Haryana was granted recognition for the following courses:-

1. NRC order no. NRC/NCTE/F-7/HR-917/29150-156, dated 28.09.2007 for the B.Ed. course of one year duration with an annual intake of 100 (One Hundred Only) students.
2. NRC order no. NRC/NCTE/F-7/HR-1096/2008/45399-405 dated 19.04.2008 for the B.Ed. Add. Course of One year duration with an annual intake of existing 100+Add. 100 = 200 (Two Hundred only) students.
3. NRC order no. F.NRC/NCTE/HR-1092/50039-46 dated 14.05.2008 for the D.Ed. Course of two year duration with an annual intake of 50 (Fifty only) students.

Subsequently, the institution sought for permission for change of premises to Aastha College of Education (Co-Educational), Khewat No. 56, Khatoni No.87, Khasra No. 18/5, Village-Bhagwanpur, PO-Manka Manki, Teh.-Jagadhri, Sub Tehsil-Mustafabad, District-Yamuna Nagar, State-Haryana under clause 8(11) of the NCTE Regulations, 2009.

The Northern Regional Committee in its 216th meeting held from 27th to 28th June, 2013 finally considered the case of the institution and decided the following:-

- The original file of the Institution and visiting team report of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC and NRC decided the institution be allowed to shift the institution to its new premises under clause 8 (11) of NCTE, Regulations, 2009 for B.Ed. and D.Ed. course on co-education basis.

In view of the above the institution is allowed to shift its premises to Aastha College of Education (Co-Educational), Khewat No. 56, Khatoni No.87, Khasra No. 18/5, Village-Bhagwanpur, PO-Manka Manki, Teh.-Jagadhri, Sub Tehsil-Mustafabad, District-Yamuna Nagar, State-Haryana under clause 8(11) of the NCTE Regulation 2009.
